CASE STUDIES: AMERICAS



\$25,000 Children of Fallen Patriots, United States

In alignment with the Foundation's mission to promote educational opportunity, we proudly made a \$25,000 grant to Children of Fallen Patriots, an organization providing college scholarships and educational counselling to military children who have lost a parent in the line of duty. The grant from the Duff & Phelps Charitable Foundation will cover the full, four-year college tuition for one of the scholars.

By working directly in nearly 2,500 schools in the U.S. to bring community resources inside schools, CIS helps the most vulnerable students stay in school and succeed in life. The organization was nominated by Atlanta-based Duff & Phelps employee.

CASE STUDIES: APAC



\$14,000

Rotary Sanskardham Academy, India

Since 1995, Rotary Sanskardham Academy has been helping the hearing-impaired face the world with confidence. The registered educational institution trains hearing-impaired individuals from preschool up to degree college. Some of these hearing-impaired children have other disabilities such as spasticity, speech defects and learning challenges. Rotary Sanskardham Academy aims to ensure all children with special needs are educated, independent, productive and respectable citizens of India. The institute's focus is not just on academic achievements but also on total personality development. It helps nurture the children's inherent talent enabling them to excel in the fields of arts, music, dance and sports.

Aidha, Singapore

Aidha, a Singapore-based, award-winning charity, is a two-time recipient of the Duff & Phelps Charitable Foundation grant. Aidha's mission is to help foreign domestic workers and low-income Singaporean women achieve economic independence through financial education, wealth creation and entrepreneurship. In 2019, Duff & Phelps partnered with Aidha for the 42km sportive ride at OCBC Cycle—one of the biggest mass cycle events in Singapore—to raise awareness and funds to support Aidha's life-changing financial education programs. Out of the 6,800 participants at OCBC Cycle, 100 were part of Aidha's Tour De Singapore group. All Duff & Phelps volunteers completed the OCBC Cycle ride and Team Aidha was awarded the Longest Distance Award for cycling a total of 3,402 km.

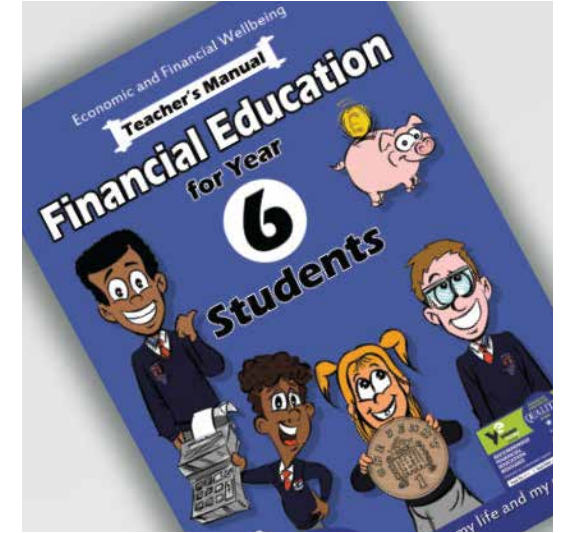

Basis.Point, Ireland

Basis.point was established in Dublin, Ireland in 2013 to improve the lives of those who suffer systemic issues with education. The charity is the initiative of the Irish Funds Industry and it works with other charity partners to achieve greater impact and outreach. The Duff & Phelps Charitable Foundation 2019 grant was used to facilitate a numeracy program for children between ages 8-14 years in disadvantaged schools and communities in Dublin. These children are most at risk of falling behind their peers and struggling within the education system. The program is designed for mentors to work one-on-one with these children and give a personalized approach to learning.

"We discussed Seán's (aged 8) likes, and applied maths to them; for example, the cost of a football match ticket, food for the game, fraction of players in defense versus attack and midfield positions, etc. He seemed to really enjoy the different, personal approach."

City Pay it Forward, United Kingdom

City Pay it Forward is a nonprofit organization that seeks to bring financial education into primary schools in order to better equip children to understand and manage their money. Working in partnership with a number of leading educators and Rising Stars, part of Hodder Education, one of the largest educational publishers in the UK, the charity developed a comprehensive year 6 curriculum that is available for free to teachers and schools across the UK. In total, almost 700,000 children in 21,000 schools will now have access to City Pay it Forward's materials, made possible by the contribution from the Duff & Phelps Charitable Foundation.

"Research tells us that four in ten adults are not in control of their finances and average debt-to-income ratio for 17–24-year olds now stands at nearly 70%. These startling figures demonstrate the need to equip younger generations with the tools to understand and manage their finances effectively. Even though recent studies found that money habits are formed by the age of seven, financial education is not statutory. We believe it's essential to begin the educational process at an early age and that's why we're providing this free curriculum to every single primary school in the UK"
