PLL 1 Realisations 2021 Limited (Formerly Pure Legal Limited) (in Administration) (“PLL” or “the Company”)
Company Number: 09511435

I write to you further to our previous correspondence in respect of my appointment as Joint Administrator of the Company, together with Michael Lennon and James Saunders on 2 November 2021.

As you are aware, immediately following our appointment, PLL ceased to carry out any further legal work. Whilst you had signed a Conditional Fee Agreement (“CFA”) with PLL, it had not opened a legal file or undertaken any work in relation to your claim. PLL was therefore no longer able to act for you in relation to your case, as a result of the Administration.

In order to ensure that your matter was being progressed, we made arrangements to transfer PLL’s interest in your CFA to Parkerwall Limited. Whilst Parkerwall signed the agreement for the transfer of your file, they failed to engage with you directly and have subsequently entered into Liquidation and also ceased trading. As there is no agreement between you and Parkerwall, we have deemed your file to remain with PLL.

Since Parkerwall entered into Liquidation, we have made further attempts to transfer your case to another solicitor to progress, but we have not had any success in finding someone who will take your case on. As such, the Joint Administrators have made the decision to terminate your case and consequently are unable to assist with your claim any further.

I advise that neither PLL nor the Joint Administrators can provide any legal advice to you whether in relation to your claim or otherwise and you remain entirely within your rights to seek alternative legal advice to pursue your claim.
